## **Building Department Fee Schedule**

This policy is to clarify the City of Jackson Building Department fee amounts and how they are obtained. This fee schedule follows the permitting guidelines set out in the International Building code, various state regulations and is intended to recover departmental costs.

1. Calculation Fee Multiplier is based on Construction Cost and Department Revenue. The City of Jackson Building Department operates on a fee factor of 0.024 times the valuation of the project as determined by the 2017 ICC valuation table (attached) and the square footage of the project. The last valuation table was adopted in 2017 based upon City Resolution #2017-35.

Permit Fee = Gross Area x ICC Square Foot Construction Cost X \$0.024

- 2. The Plan Check Fee will be calculated at 65% of the Permit Fee. The Plan Check fee will be due when the permit is submitted for review and is non-refundable. Remaining and additional fees will be due after Plan Check is complete before the permit is issued.
- 3. It is the owner and contractors' responsibility to obtain a permit or verify that one is not needed for the scope of work. Double fees will be applied to any project that is started without a permit or goes outside the permitted scope of the project. This will include ALL fees collected by the City.
- 4. The Technology, Administration, Software and Communications fee will be added to all permits issued. This fee was encouraged by the California Building Standards Commission to make the building permit process more accessible and user-friendly for consumers in local jurisdictions. This fee is used for the on-line building portal, the building department database, and for cloud-based storage and updates. The T.A.S.C. fee is currently calculated at 0.00565 of the project valuation.
- 5. SB1473 Calderon Fee This State fee requires cities and counties to collect a fee on building permit applicants, in the amount of \$1 per every \$25,000 in valuation. The City retains 10% of the fees collected for administrative costs and code enforcement education, while the remainder goes to the Building Standards Commission for the purpose of funding the development of building standards.

- 6. The California Strong Motion Instrumentation Program is a fee that will be added to all permits issued. The data is used to develop recommended changes to seismic provisions of building codes, to assist local governments in their general plan process and to aid emergency response personnel in the event of a disaster. Five percent of the fees collected stay in the local jurisdiction. The CA SMIP fee is currently calculated at 0.00013 times the valuation amount for residential and 0.00028 times the valuation for commercial projects.
- 7. Permit fees for solar are capped per CA AB 1414. Roof top Systems are limited to \$450 plus state fees. Ground mount systems are limited to \$550 plus state fees to cover the extra inspections for footings and trenches. This does not limit additional fees for reinspection or additional plan check due to changes or work requiring corrections.
- 8. The ICC does not intend for all permits to be based on valuation. The BVD is not intended to apply to alterations or repairs to existing buildings. The building department would like to implement a set schedule of fees for certain permits as listed below. This will place the City's building department fees in line with surrounding jurisdictions. This schedule complies with AB 1414 for solar project fees.
